

BUTTERWICK 'RUNWAY Rivals' COMPETITION TERMS AND CONDITIONS

TERMS AND CONDITIONS

Promoter: Butterwick Hospice Care, Middlefield Road, Stockton on Tees, TS19 8XN. Registered Charity Number 1044816

Eligibility

1. The competition is open to residents of England, Wales and Scotland.
2. Entrants must be 18 years old or over. In entering the competition, you confirm that you are eligible to do so. The Promoter may require you to provide proof that you are eligible to enter the competition.

The Competition

3. The competition begins at 9am on the 18/09/2020 and stage 1 closes at midday on 30/10/2020. Stage 2 closes at midday on 01/12/2020.
4. Runway Rivals is a virtual fashion show in which entrants will pick a category and post a photo online of an outfit to match the requirements of that category.
5. 30 'Finalists' will be chosen from the entrants on 30/10/2020 to move forwards to battle it out as 'Rivals'. Finalists will be chosen by a panel of independent adjudicators. The decision of the independent judges (acting reasonably) will be final.
6. Runway Rival Finalists will have from 30/10/2020 until 01/12/2020 to raise as much money and awareness of Butterwick Hospice Care as possible through their own third party activities.
7. From those 30 Finalists, there will be one winner per category, chosen by a panel of independent adjudicators. Winners will be chosen on merit from the range of activity they have undertaken during Runway Rivals. The decision of the independent judges (acting reasonably) will be final.
8. One overall winner (The King / Queen of the Runway) will receive the main prize from our Headline Sponsor - a photoshoot with Katiemorris.photography including hair and makeup and be featured in our 2021 Magazine as the face of Butterwick Retail.
9. By entering this competition all entrants will be deemed to have accepted and be bound by these terms and conditions. All entry instructions form part of these terms and conditions.

Entry

10. To enter, entrants must complete the online registration form, providing full name, a valid email address, telephone number and a photograph of yourself wearing the outfit(s) you have chosen.
11. The entries will be judged after Stage 1 (week ending 30/10/2020) to choose the 30 finalists. Runway Rivals finalists will be judged week commencing 30/11/2020. Winners will be announced week commencing 07/12/2020.
12. You agree that the Promoter may, but is not required to, make your entry available on its website and any other media. You agree to grant the Promoter a nonexclusive, worldwide, irrevocable licence, for the full period of any intellectual property rights in the competition entry and any accompanying materials, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the competition entry and any accompanying materials for such purposes.

13. Entry fees are £5 per category entered. Multiple entries will be accepted and will be subject to multiple entry fees paid.

Prize

14. All entrants will receive a certificate of entry

15. Runners up will receive a trophy

The Promoter reserves the right to publicise the winning entrants name and photograph on the Promoter's website to announce the winner of this competition and for any other reasonable and related promotional purposes and you agree to participate in any reasonable publicity required by the Promoter

17. All unsuccessful entries will not be published, but all those taking part will receive a certificate of entry.

18. In the event of unforeseen circumstances the Promoter reserves the right to provide alternative prizes of equal or greater value.

19. Category prizes will be provided by sponsors and awarded to 5 finalists of Runway Rivals. The prizes are subject to availability.

20. One overall winner (The King / Queen of the Runway) will receive the main prize from our Headline Sponsor, a photoshoot with Katiemorris.photography including hair and makeup to be featured in our 2021 Magazine and become the face of Butterwick Retail.

Winner Announcement

21. The prize winner will be notified within fourteen (14) days of the Closing Date to the email address submitted by the prize winner. To claim the prize, each prize winner must within 48 hours of notification from the Promoter confirm acceptance of the prize.

22. If the Promoter is unable to contact the prize winner or if the prize winner does not confirm acceptance of the prize, the Promoter reserves the right to offer the prize to the next eligible entrant selected from the remaining entries that were received before the Closing Date.
